### **II. RESPONSIBILITIES OF THE ASSOCIATION**

- A. ASSOCIATION can invite the faculty members of the INSTITUTION to impart training for their stake holders.
- B. ASSOCIATION can get the guidance and direction for their Scholars from the INSTITUTION.
- C. ASSOCIATION can get suggestions from INSTITUTION for their expansion activities in the field of Research.
- D. ASSOCIATION can use INSTITUTION to conduct surveys for identification of general issues in the market.

### **III. TERMS AND CONDITIONS**

- A. This MOU will take effect from the date it is signed by the representatives of the ASSOCIATION and the INSTITUTION.
- B. This MOU will be valid for five years and may be continued after suitable review and agreement.
- C. This MOU will end on mutual consent of the ASSOCIATION and the INSTITUTION.

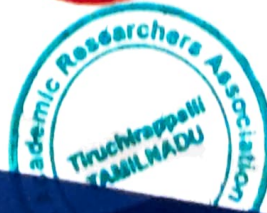
